General Reproduction and Publishing Request Policies

1. User understands Mount Gretna Area Historical Society, hereafter referred to as MGAHS, reserves the right to refuse to: copy any item that may be damaged by the reproduction process; copy items that are restricted by copyright; limit the number of photographic copies, photocopies or scans; and charge different fees than those currently published by MGAHS.
2. Documents and images belonging to MGAHS may not be placed under the protection of copyright by the purchaser of such images, his or hers heirs, assigns, or agents.
3. User agrees that all reproductions of the materials from the MGAHS collection can only be obtained from MGAHS. User agrees that reproductions taken from printed or electronic items not supplied directly by MGAHS are strictly prohibited.
4. Photographic work for any and all purposes will be done by a photographer selected or authorized by MGAHS under its supervision at a location approved by MGAHS.
5. Patrons wishing to have images saved to CD should specify resolution and the type of file (JPEG, TIFF, etc.) required. Those wishing to have images emailed should also specify resolution, but only JPEG images can be sent via email.
6. User will not use the materials for any purpose whatsoever including all forms of publications, media, or exhibits unless a permission to publish is granted by MGAHS.
7. Permission to reproduce covers only the specific occasion and use stated on the permission form. Additional use of any kind, including reprints, further editions, etc., will require reapplication.
8. The full credit line, "Courtesy of Mount Gretna Area Historical Society, Mount Gretna, Pennsylvania," must be printed adjacent to the printed material and must appear for each reproduction.
9. If an image is not published in its entirety, that is, if cropped in any way, the caption must include the word "detail" as well as the full credit line.
10. MGAHS requests that the requestor furnish one complimentary copy of the issue of the periodical or book in which the reproduction(s) appear.
11. User hereby agrees to indemnify, defend and hold harmless the historical society and its employees from and against all liability, whether legal or otherwise, including costs and expenses arising from use of the materials, whether based on violation of rights of ownership, infringement of copyright or trademark, or invasion of the rights of privacy, law of libel or any other claim.

Reproduction Fee Schedule

All scanning of material from the collections of Mount Gretna Area Historical Society is completed by MGAHS staff. Eligibility for item scanning is based upon the condition and size of the item. Images can be saved in TIFF or JPEG formats. Resolution range is between 50 and 1200 dpi. If no format or resolution is specified, images will be saved in JPEG format and scanned at 300 dpi. The charges must be paid in full upon receipt of invoice. **Use fees are non-refundable.**
